Virginia Conservation Lobby Days - January 30 & 31, 2024

Ellen Buoyer, Fran McDermott, & Cabell West represented TGC at Virginia's General Assembly Session. We met with State Senator Lamont Bagby and Luke Sweeney, legislative aide to House Representative Betsy B. Carr, to ask for their support on key GCV recommended environmental bills, such as tree conservation during land development, funds for forest sustainability, invasive species management, and monitoring & reporting of PFAs (toxic "forever" chemicals) by manufacturers.

Finance/Kathy Watson and Ellen Buoyer

Finance committee will present the proposed budget for 2024-2025 at the Board meeting on 2/28 for Board approval. In addition we are proposing a \$25 Assessment on dues for Actives and Sustainers in order to raise funds for our upcoming GCA and GCV meetings. We will host the GCV Annual meeting in 2028 as well as our Centennial Celebration. We will host the GCA Zone 7 meeting in 2030. The registration fees for these meetings do not begin to cover the total cost of hosting these meetings. Many long time members will remember the assessments we had for our last meetings. We currently have \$13,000+ in our reserves for these future meetings, but need to start preparing more aggressively and hope to keep the assessment at this level going forward if at all possible.

Discussion on Proposed changes to Membership By-Laws:

- Allow Executive Committee Members, excluding the President, to propose or endorse one candidate each year.
- An Active member may Propose one member or Endorse one member, but not both in the same year. Working on with ByLaws to present new language in March meeting.
- Remove the age (65 years) at which members may transition to Sustainer. Keep language "15 years or at the discretion of the Board"
- Reminder that Change in Membership Status is due March 31st. Our Sustainer List will be presented at the April Board meeting and, per our ByLaws, the Board determines the positions/transition of those on that list -taking into account date requested and participation over their 15+ years of membership, A current list of Membership Status and change requests will be presented at the April 3 Board meeting.
- Additionally, the Membership Committee would like to suggest a very thorough and continued review of the complete Membership Section of the ByLaws next year. There continue to be some discrepancies that should be addressed.

Flower Hour:

The Membership Committee met and developed the following parameters around Flower Hour:

- *The group will remain legacy members only at this point.
- *Members of TGC will be billed for their FH participant in September for the year.
- *A letter to all the FH members will be sent in September outlining the volunteer opportunities/commitment, dates and programming
- *We are adding one volunteer shift opportunity (HGW or Spring Sale or other)for each of the FH ladies.
- *FH ladies are being invited to join(and pay at their own expense) the Kent Russell event at Kellv's.
